### **School Fees Payment Terms**

- 1. A one-time non-refundable Registration Fee is payable for student enrolling for the first time. The fee must be paid to secure the place for a child in the school. The due date is one week after the offer letter has been accepted and before the term begins.
- A Sibling Discount of 7.5% is applicable on Tuition Fees for the Second child, Third child 17.5% and Fourth child onwards 30%.
- 3. Alumni Discount of 7.5% is applicable on Tuition fees for the first child, Second child 17.5% and Third child onwards 30%
- 4. Fees is payable before the first day of the term.
- 5. No students will be allowed to roll over fee balances to the next term.
- 6. Early payment discount of 3% is applicable for tuition fees paid in full by the first day of the term.
- 7. Fees for Year 11, 12 and 13 are billed twice per year i.e., September and January term.
- 8. The School will charge a monthly fee of 3% on outstanding fees balance after end of the first month of opening the school.
- 9. If full fees for the term is not cleared after midterm break, the student will not be allowed to attend classes as well as participate in other activities undertaken by the school.
- 10. Any new request for Transport and/or Lunch and withdrawal from the same services should be made in writing to the School.
- 11. Any payment made will be first allocated to tuition fees.
- 12. Examination Fees, BTEC Assessment fees, school activities, field trips and other optional trips for which the parents will be invoiced separately. The information on the stated areas will be shared with parents within a reasonable time. These payments shall be paid before or by the due date communicated.
- 13. The School does not accept **Cash Payments**. All payments must be made by direct bank bank transfer or Mpesa. Parents must provide the Accounts Office (accounts@rusinga.ac.ke), with a hard or electronic copy of the proof payment showing the family file number to avoid delay in crediting your accounts.
- 14. Any dishonoured cheque from the parent will attract a penalty of **Ksh 3,000** and will affect the credit rating of the parent.
- 15. If a parent wishes to withdraw their child from the School, one term's advance notice of withdrawal must be given in writing or one term's fees in lieu of notice is payable. School clearance will not be complete until all outstanding dues is settled in full.
- 16. The School reserves the right to appoint a debt collector where the fees fall in arrears for more than one term. For those withdrawing from the School with outstanding fees balance and the school efforts have not yielded any positive response from the parents, then the school will take other measures including legal recourse to enforce debt collection.
- 17. The School reserves the right to review the school fees annually.
